**AMENDMENT TO RESOLUTION ESTABLISHING THE MILLAGES FOR
FAIRFIELD COUNTY FOR THE FISCAL YEAR 2013-2014, ADOPTED MAY 13, 2013.**

WHEREAS, Fairfield County Council, **Ordinance No. 615**, has established the amount of taxes to be collected for various County agencies in Fiscal Year 2013-2014 and has stipulated that the County Council would establish the required millage rate by Resolution;

NOW THEREFORE, BE IT RESOLVED, that the following millages are hereby established by the Fairfield County Council for Fiscal Year 2013-2014.
