## 6. OLD BUSINESS

**A. Second Reading: Ordinance No. 523 -** An Ordinance To Amend The Fairfield County Zoning Ordinance (No. 498), To Provide For The Zoning Reclassification From R-1 (Single Family Residential) To RD (Rural Resource District), Of Eleven And Fifty-Two Hundredths (11.52) Acres, Owned By Carlos Alexander, Tax Map No. 079-00-00-003, Located At 750 Shangri-La Drive, Winnsboro, S. C., 29180. *It was moved by Mr. Brown; seconded by Mr. Branham to approve Second Reading of Ordinance No. 523. The motion carried unanimously.*

### **12.** COUNTY COUNCIL TIME

Ferguson: Commented that the Greenbrier Fire Department received grant for new fire truck. Announced the official opening of the Moultrie Street sidewalk. Gave a report of his and Mr. Hinely's attendance at the Interbasin Water Transfer meeting in Charlotte. Brought up issues with contracting out grass cutting in the County.

Murphy: Echoed the good job done on the Moultrie Street sidewalk. Brought up another safety issue of no sidewalks present on either side of the road from Bi-Lo coming to the high school. Also addressed several areas throughout the county that has speed limit of 55 mph, particularly around churches and playgrounds. Asked that these areas be surveyed to reduce the speed limit in those areas. Addressed the presence of tall grass on Longleaf Road.

Kinley: Extended congratulations to Mr. Vessa Jackson for placing first in the Fire Chiefs Competition. Commented on the letter from Wilbur and Betty Collins expressing their appreciation to the fire service.

Murphy: Brought up the fact about getting proper information out about the role of EMS and their response time. Mr. Hinely was asked to give a report on the EMS response time relative to the murder in Blair. Mr. Murphy addressed a folder containing a letter marked "attorney-client privilege" and asked for an explanation of that notation. Mr. Hinely indicated Mr. Sprott was out sick and had asked to be excused; therefore, he (Hinely) could inquire of Mr. Sprott tomorrow.

Marcharia: Asked the Council to consider, in its negotiations with SCE&G, to

put that agreement under the Council's authority.
