She set forth that she has a small area over in Mitford (six houses on one street); in one of those houses, there are thirty (30) dogs. Would like to find out something about the ordinance so that could be addressed. The next item was that she is aware of a leash law within the Town, and at some point, this was addressed in the County. She stated there are roads in the rural areas where people go out and can walk with their dogs; however, it is getting to the place where they can't do that because people do not let their dogs stay in a confined area and running loose. Would like to find out what is in place that may be able to address that.

Members of Council commented on the wonderful Veterans Day celebration. Council Member Brown proposed that Council reconsider the days off in the future to include Veterans Day in honor of the veterans.
