

MINUTES REGULAR MEETING FAIRFIELD COUNTY COUNCIL NOVEMBER 29, 2010

In accordance with the South Carolina Code of Laws, 1976, Section 30-4-80 (e), as amended, the following persons and/or organizations have been notified of the time, date, and location of this meeting: The <u>Herald-Independent</u>, <u>The State</u>, and Winnsboro Cablevision, and fifty individuals.

1. CALL TO ORDER

Chairman Brown called the meeting to order at 6:06 P.M.

2. INVOCATION

Council Member Kinley led in the invocation.

3. APPROVAL OF MINUTES

It was moved by Council Member Ferguson; seconded by Vice Chairman Trapp to approve the minutes of the regular meeting of November 22, 2010. The motion carried unanimously.

4. COMMITTEE REPORTS

A. Administration and Finance

Committee Chairman Robinson reported the committee met to discuss the request of the Dutchman Creek Volunteer Fire Department. The request was for the county to assist in building a fire substation. The recommendation of the committee, and so moved by Committee Chairman Robinson, was allow Mr. Hinely and the fire department to work up a proposal to allow the erection of a 30' x 50' pole building at 2414 River Road. The proposal would include the county's match up to \$20,000.00 for a term of two (2) years, beginning July 1, and that the county would own the property. The motion was seconded During discussion, Chairman Brown set forth that this will by Council Member Perry. affect 175 homes and will take the ISO rating from a ten down to a five for those homes, which will be a major insurance savings. Council Member Marcharia maintained that he supported any endeavor that would enhance the quality of life and safety of the citizens of Fairfield County. He added that he had previously asked how many structures in the last five years have been saved, given to the amount of money that is put into the fire budget. He set forth the poor condition of the Jenkinsville Fire Department and stressed he was disturbed about not being able to protect that community. The motion carried unanimously.

PRESENTATION

- □ Dutchman's Creek Volunteer Fire Department Mr. Ned Gwin
 - Will be located at 2414 River Road.
 - Study was done in March, 2008 and it was determined that a substation located on River Road near Rock Hill Baptist Church would take approximately 175 structures from an ISO rating of 10 to a rating of 5. This would place these structures within five road miles of a station.
 - About haif the beneficiaries of this station Durham Place and the side streets, White Oak Church Road, River Road from the substation to US 21, Great North Road, part of US 21 between Ridgeway and Mitford. The other half would be in an area beyond Cedar Point Road. This includes Wateree Creek Valley, Woodside, Wateree Keys and Gunsite.
 - According to information provided by the Fire Marshal, a wood frame house insured for \$250,000 would have a premium of \$3,469.00 with a rating of 10. If it goes to a 5, this would drop to \$961.00.
 - At a minimum, want to build a 30 x 50 heated pole building, at a cost of approximately \$30,000. Since the county agreed to assist up to \$20,000, Dutchman's Creek may choose to put in water and a restroom, etc.
 - Would house one of the existing fire engines in it. There would be no requirement for additional equipment to be purchased. Recently, Dutchman's Creek received a grant for a fire engine, which is currently in Columbia. It has a 2,500 gallon water capacity, which will assist the other stations around the area (tanker and pumper). Hope to get this in possession soon.
 - The property is currently owned by Dutchman's Creek Volunteer Fire Department. The title will be transferred over to the county.

- ? Hopefully legislation will pass for training to be offered on the website, which will help volunteers who cannot go on Saturday or whenever training is currently being offered.
