**A. Third and Final Reading: Ordinance No. 580** – An Ordinance To Amend The Fairfield County Zoning Ordinance (No. 498) To Provide For The Zoning Reclassification From RD (Rural Development) To B-2 (General Business) Of One And Eleven Hundredths (1.11) Acres, Owned By Bobby D. And Donna Street. Applicant Is AB&D Services, Tax Map No. 192-00-00-014. Property Is Located At 955 Jenkinsville Road, Jenkinsville, SC, 29065. *It was moved by Council Member Marcharia; seconded by Council Member Trapp to approve Third and Final Reading of Ordinance No. 580.
