GENERAL CONDITIONS

1. BID INSTRUCTIONS AND SUBMITTAL:

- a. Bids shall be publicly opened at the time and place as indicated in the Notice to Contractors.
- b. Sealed bids shall be enclosed and secured in an envelope bearing the markings as described under Bid Submittals in the <u>Notice to Contractors</u>. Bids shall be addressed to the Fairfield County Procurement Office, Attention: Ms. Cathy Washington, County Administrative Building, 2nd Floor 350 Columbia Road, Winnsboro, SC 29180. Hand carried bids will be deposited in the red mailbox at entrance of the County Administration Building.
- c. Bids shall be submitted no later than <u>May 26, 2020, at 10:00 AM</u>, if <u>mailed or hand delivered</u> in the places and manners as described in paragraph b above and on the date indicated by the <u>Notice to Contractors</u>. Bids received after these times are considered late bids. Late bids <u>shall not</u> be considered unless the delay was caused by improper handling by the County's employees.
- d. The County shall not accept responsibility for unidentified bids.
- e. In the event that a bid is unintentionally opened prior to the official time set for the bid opening, the employee opening such bid shall immediately inform the Procurement Officer or his/her assistant who shall, in the presence of another of equal rank or above, immediately contact the vendor submitting the bid.
- f. The vendor so contacted will be informed as to the circumstances and shall be invited to come to the office of Procurement to reseal and submit or withdraw the bid, if the vendor elects to reseal and submit the bid, such vendor shall be required to sign, date and indicate the time of resealing on the bid envelope. If the vendor directs the Procurement Office to reseal the bid, both the employee making the contact to the vendor and the owner witness present, shall sign, date and indicate the time of sealing on the bid envelope.
- g. In the event that the Procurement Office is directed by the vendor to return the bid, a statement properly witnessed stating the action taken and when, shall be duly filed.
- h. All prices and quotations shall be entered in ink or typewritten and shall remain firm for no less than sixty (60) days from the date of the bid. Mistakes may be crossed out and corrections inserted adjacent there to and shall be initialed in ink by the person signing the bid. The bidder shall insert the net price per stated unit and the extension against each item, which he/she proposed to deliver. The price shall include in the grand total column all delivery charges, installation and applicable taxes when necessary.
- Bids Will Not Be Considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended).
- j. Bids Will Not Be Considered unless accompanied by a sealed, bidder's bond, for 5 percent (5%) of the amount of the bid. Bid bond will be duly executed by the bidder as principal & having as surety thereon a surety company licensed to do business in the State of South Carolina. Successful bidder will be required to furnish a satisfactory performance & payment bond each in the amount of 100 percent (100%) of the bid.
- k. The County Reserves the Right to accept or reject any & all responses, to waive technicalities & informalities, to negotiate further with the Contractor of its choice, & to request additional information, to interview & to make an award deemed in its own best interest. Due to county no meeting policy, the procurement officer will open the bids in her office with witnesses present If contractor will put an email address on bid envelop, a copy of read out bids will be emailed to all bidders as ASAP opening. Same document should be on county website by 10:30 AM.

All submittals shall become property of the County and is subject to the Freedom of Information Act (FOIA) regulations.

GENERAL CONSTRUCTION NOTES:

- 1. BASE DATA AND SURVEY INFORMATION UPON WHICH THIS PLAN IS BASED HAS BEEN PROVIDED BY OTHERS. ALAN GLASSBERG, LLC. ASSUMES NO LIABILITY FOR ITS ACCURACY OR COMPLETENESS. CONTRACTOR IS RESPONSIBLE FOR VERIFICATION OF ALL PERTINENT INFORMATION.
- 2. IT WLL BE THE CONTRACTOR'S RESPONSIBILITY TO ASCERTAIN ALL PHYSICAL LOCATIONS OF UTILITY LINES PRIOR TO THE TIME OF CONSTRUCTION. CONTRACTOR IS RESPONSIBLE FOR THE COST OF REPAIRING ANY EXISTING UTILITIES DAMAGED DURING HIS WORK.
- 3. CONTRACTOR WILL RESTORE TO ORIGINAL CONDITION, AND TO THE SATISFACTION OF THE LANDSCAPE ARCHITECT, ANY AREA DISTURBED OUTSIDE THE LIMIT OF WORK. CONTRACTOR WILL REPAIR ANY DAMAGES OUTSIDE THE LIMIT OF WORK RESULTING FROM HIS WORK, AT THE CONTRACTOR'S EXPENSE.
- 4. CONTRACTOR WILL NOT DAMAGE ANY EXISTING TREES AND SHRUBS TO REMAIN INCLUDING THE SCARRING AND SCRAPING OF TRUNKS OR LIMBS; THE BREAKING OF TRUNKS AND LIMBS: SPILLING OF FUEL, OIL OR OTHER CHEMICALS; THE COMPACTION OF ROOT ZONES AND BURNING FROM ENGINE EXHAUSTS. APPROVED TREE PROTECTION FENCING SHALL BE ERECTED AROUND SIGNIFICANT TREES, AND AS DETERMINED BY THE LANDSCAPE ARCHITECT, WITHIN THE LIMITS OF WORK.
- 5. CONTRACTOR WILL BE RESPONSIBLE FOR VISITING THE SITE DURING HIS BID PREPARATION AND FULLY FAMILIARIZE THEMSELVES WITH ALL ASPECTS OF THE SCOPE OF WORK AND CONDITIONS OF THE SITE, INCLUDING BUT NOT LIMITED TO, UTILITIES, GRADING, ACCESS, ETC.
- 6. CONTRACTOR WILL COORDINATE HIS WORK WITH THAT OF OTHER TRADES EMPLOYED BY THE OWNER AND WITH THE OWNER'S OWN FORCES.

- 8. CONTRACTOR WILL OBTAIN ALL NECESSARY PERMITS FOR CONSTRUCTION OF THIS PROJECT.
- 9. CONTRACTOR SHALL DISPOSE OF ALL WASTE SAFELY AND LEGALLY OFF-SITE.
- 10. CONTRACTOR WILL DESIGNATE AND USE ONE LOCATION WITHIN THE CONTRACT LIMIT OF WORK FOR CONCRETE TRUCK DISPOSAL AND WASHING. ALL WASTE SHALL BE REMOVED AND LEGALLY DISPOSED OF AT COMPLETION OF WORK.
- 11. CONTRACTOR WILL BE RESPONSIBLE FOR SECURITY OF HIS OWN EQUIPMENT AND MATERIALS.
- 12. CONTRACTOR WILL PROVIDE ALL NECESSARY FLAG MEN, BARRICADES, SIGNS, AND WARNING DEVICES FOR THE PROTECTION OF THE PUBLIC AND/OR OWNER.
- 13. REFERENCE MADE TO "ARCHITECT" IN DRAWINGS AND SPECIFICATIONS WILL BE DEFINED AS "LANDSCAPE ARCHITECT."
- 14. NO CHANGE TO ANY ASPECT OF THESE CONTRACT DRAWINGS SHALL BE MADE WITHOUT PRIOR APPROVAL OF THE OWNER/OWNER'S REPRESENTATIVE AND LANDSCAPE ARCHITECT.
- 15. ALL MEASUREMENTS ARE TO THE BACK OF CURB (BOC), EDGE OF PAVEMENT (EOP), CENTERLINE, FACE OF WALLS, OR THE FACE OF COLUMN UNLESS OTHERWISE NOTED ON THE PLANS.
- 16. STREETS ADJACENT TO AND DIRECTLY AFFECTED BY CONSTRUCTION TRAFFIC SHALL REMAIN FREE OF SOIL AND SILT, OTHER CONSTRUCTION DEBRIS AND TRASH. CONTRACTOR IS RESPONSIBLE FOR MAINTAINING REASONABLE CLEANLINESS OF SAID STREETS BY WASHING DOWN WITH WATER (WHEN NECESSARY) AND REMOVING ANY OTHER TRASH, WASTE OR CONSTRUCTION DEBRIS, AND DISPOSING OF IT PROPERLY ON A DAILY BASIS.

ALL DAMAGE SHALL BE REPAIRED AT THE CONTRACTOR'S EXPENSE.
- 19. DO NOT SCALE DIRECTLY FROM DRAWINGS; USE THE WRITTEN DIMENSIONS PROVIDED. IN THE EVENT NO WRITTEN DIMENSION EXISTS, CONTACT THE LANDSCAPE ARCHITECT.
- 20. SHOP DRAWINGS MUST BE CHECKED, APPROVED AND STAMPED BY THE CONTRACTOR PRIOR TO SUBMISSION TO THE LANDSCAPE ARCHITECT FOR APPROVAL. SHOP DRAWINGS MUST BE APPROVED BY LANDSCAPE ARCHITECT PRIOR TO CONSTRUCTION.
- 21. ALL WORK IS TO BE PERFORMED IN ACCORDANCE WITH ALL FEDERAL, STATE, COUNTY AND LOCAL MUNICIPAL CODES, ORDINANCES AND REGULATIONS.
- 22. CONTRACTOR TO INSTALL ALL ITEMS CONTAINED WITHIN THESE DRAWINGS, UNLESS OTHERWISE INDICATED AS "N.I.C." (NOT IN CONTRACT)

DEMOLITION NOTES:

- 1. CONTRACTOR SHALL VERIFY ALL ITEMS TO BE DEMOLISHED AND REMOVED FROM THE PROJECT SITE. THE VERIFICATION PROCESS SHALL INCLUDE VISITING AND WALKING THE SITE. ALL ITEMS REQUIRING DEMOLITION/REMOVAL, OTHER THAN REMOVAL OF CHAINLINK FENCE AND HEDGE ADJACENT TO THE BURGER KING PARKING LOT WHETHER SHOWN ON THIS PLAN OR NOT, SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR.
- 2. ALL EXISTING STRUCTURES AND RELATED FOOTINGS, FOUNDATIONS, STEPS, ETC. ARE TO BE REMOVED FROM THE SITE BY THE CONTRACTOR AND DISPOSED OF ACCORDING TO ALL APPLICABLE FEDERAL, STATE, COUNTY AND LOCAL MUNICIPAL CODES, ORDINANCES AND REGULATIONS.
- 3. CONTRACTOR SHALL CONSULT THE OWNER OR LANDSCAPE ARCHITECT REGARDING SALVAGE AND DELIVERY OF ANY ITEMS. ANY ITEMS NOT RETAINED SHALL BE THE CONTRACTOR'S RESPONSIBILITY TO DEMOLISH AND/OR LEGALLY DISPOSE OF.
- 4. IF ANY HAZARDOUS MATERIALS ARE ENCOUNTERED DURING DEMOLITION THE CONTRACTOR SHALL COORDINATE WITH THE OWNER/LANDSCAPE ARCHITECT AND ALL APPROPRIATE AGENCIES TO ENSURE PROPER AND SAFE REMOVAL AND DISPOSAL.
- 5. THERE SHALL BE NO BURNING ON-SITE UNLESS THE LOCAL MUNICIPALITY AND OWNER APPROVES AND PERMITS THE BURNING.
- 6. WHEN REMOVING A PORTION OF EXISTING ASPHALT OR OTHER HARDSCAPE, SAW CUT EXISTING HARDSCAPE TO A CLEAN EDGE.

PLANTING NOTES:

- 1. MATERIALS LIST WAS PREPARED FOR ESTIMATING PURPOSES ONLY, CONTRACTOR SHALL MAKE OWN QUANTITY TAKEOFF USING DRAWINGS AND SPECIFICATIONS TO DETERMINE QUANTITIES. ANY DISCREPANCIES SHALL BE REPORTED BY THE CONTRACTOR TO THE LANDSCAPE ARCHITECT. LANDSCAPE ARCHITECT ASSUMES NO LIABILITY FOR QUANTITY DISCREPANCIES.
- 2. CONTRACTOR TO VERIFY THAT ALL PLANT MATERIALS ARE AVAILABLE, AS SPECIFIED, WHEN PROPOSAL IS SUBMITTED.
- 3. PRIOR TO COMMENCING CLEARING AND GRUBBING, ALL TREES TO BE PRESERVED SHALL BE FLAGGED WITH BLUE RIBBON ENCIRCLING THE TRUNK. IMMEDIATELY FOLLOWING THE FLAGGING OF PRESERVED TREES, ALL TREE PROTECTION MEASURES SHALL BE INSTALLED AND INSPECTED BEFORE CONTINUING ANY SITEWORK.
- 4. CONTRACTOR SHALL TEST SOIL PH AND CONDITIONS FOR ALL SOD AND SEEDED AREAS TO ENSURE THAT PROPER SOIL REQUIREMENTS ARE MET. PLANTING BED SOILS SHALL BE AMENDED BY CONTRACTOR AS INDICATED BY SOIL TEST AND SPECIFICATIONS TO ACHIEVE PROPER SOIL CONDITIONS PRIOR TO PLANTING.
- 5. CONTRACTOR SHALL STAKE OUT ALL SHRUB BED LINES, TREE LOCATIONS, AND SHRUB GROUPINGS FOR APPROVAL BY LANDSCAPE ARCHITECT BEFORE BEGINNING PLANTING OPERATIONS.

 **(NOTIFY LANDSCAPE ARCHITECT 24 HOURS PRIOR TO PLANTING.)
- 6. ALL PLANT BEDS TO RECEIVE 3" DEEP LONGLEAF PINE STRAW MULCH. APPLICATION RATE FOR BEDS @ 1 BALE PER 50 SQUARE FEET.
- 7. CONTRACTOR TO MAINTAIN ALL AREAS WITHIN THE LIMITS OF WORK THROUGH THE DURATION OF CONSTRUCTION UNTIL FINAL ACCEPTANCE.
- 8. IN THE PLANT SCHEDULE, PLANTS NOTED AS "SPECIMEN", SHALL BE SELECTED BY THE LANDSCAPE ARCHITECT AT THE NURSERY OR PHOTOS OF THE PLANTING STOCK SHALL BE SUBMITTED TO THE LANDSCAPE ARCHITECT FOR APPROVAL.
- 9. PRE-EMERGENT HERBICIDE SUCH AS "RONSTAR G" OR EQUAL SHALL BE APPLIED TO PLANTING AREAS IMMEDIATELY FOLLOWING LANDSCAPE INSTALLATION, AND PRIOR TO MULCHING, ACCORDING TO THE MANUFACTURER'S INSTRUCTIONS.
- 10. THE PLANT BED AREAS LABELED AS "SEASONAL COLOR" SHALL BE PLANTED WITH ANNUALS AND PERENNIALS SELECTED BY THE OWNER OR LANDSCAPE ARCHITECT.
- 11. SELECTIONS AND FINAL PLACEMENT OF ALL SEASONAL COLOR BEDS SHALL BE APPROVED BY THE LANDSCAPE ARCHITECT.
- 12. ADJUST LOCATIONS OF PLANT MATERIAL TO AVOID PLACEMENT IN FRONT OF GUTTER DRAINS.
- 13. CONTRACTOR TO VERIFY THAT ADEQUATE DRAINAGE EXISTS PRIOR TO PLANTING.
- 14. ALL TREES, SHRUBS AND PLANTS SHALL BE TYPICAL FOR THE SPECIES IN FORM AND COLOR, FREE FROM DAMAGE OR DISEASE AND SHALL BE U.S. NURSERY STANDARD #1 OR BETTER.
- SPECIMEN TREES 2" CALIPER AND LARGER WILL ONLY BE ACCEPTED FROM LANDSCAPE ARCHITECT APPROVED NURSERIES. SEE NURSERY NOTES.
- 16. IF INSTALLED PLANTS SETTLE OR ARE BLOWN OUT OF PLUMB POSITION, CONTRACTOR WILL STRAIGHTEN THEM BY MAKING ADJUSTMENTS TO THE POSITION OF THE ROOT BALL, AND NOT BY PUSHING ON THE TRUNK AND/OR TIGHTENING THE GUY WIRES. TREES SHALL BE STRAIGHTENED DURING THE DURATION OF THE PROJECT AS THEY GET OUT OF PLUMB, UNTIL THE FINAL INSPECTION FOR THE CERTIFICATE OF OCCUPANCY (CO).
- 17. BALL DEPTHS ON SOME TREES IN A SINGLE GROUP MAY VARY. IN GENERAL, ROOT BALLS TO BE SET 2" 3" ABOVE EARTH FINISH GRADE. BUT, IF DEPTHS VARY, ALL TREES IN A GROUP SHOULD BE SET SO THAT THE BASE OF THE TRUNKS WILL APPEAR TO BE AT THE SAME RELATIVE ELEVATION ABOVE GRADE.
- 18. NO DECIDUOUS OR EVERGREEN TREE WILL BE ACCEPTED IF THERE IS MORE THAN ONE LEADER, UNLESS THE TREE IS SPECIFIED AS MULTI-TRUNK OR MULTI-STEM.
- 19. ALL SAUCERS SHALL BE SOAKED WITH WATER AND MULCHED IMMEDIATELY FOLLOWING INSTALLATION.
- 20. ALL ROOT BALLS REMOVED FROM CONTAINERS SHALL BE SCARIFIED PRIOR TO BACKFILLING.
- 21. ANY AND ALL EXISTING BUFFERS ARE TO BE MAINTAINED AND PROTECTED THROUGHOUT THE DURATION OF CONSTRUCTION. ANY DAMAGE TO SAID BUFFERS SHALL BE REPAIRED BY THE CONTRACTOR AND AT THE CONTRACTOR'S EXPENSE.
- 22. NO PLANT MATERIAL SUBSTITUTIONS WILL BE ACCEPTED WITHOUT APPROVAL FROM THE OWNER OR LANDSCAPE ARCHITECT PRIOR TO INSTALLATION.
- 23. THE CONTRACTOR SHALL NOT BE RESPONSIBLE, AT ANY TIME, TO REPLACE OR HONOR ANY WARRANTY FOR THE LOSS OF ANY PLANT MATERIAL CAUSED BY FIRE, FLOOD, EXTREME FREEZING TEMPERATURES, LIGHTING, WINDS ABOVE 50 MPH, OR ANY OTHER NATURAL DISASTER. NOR SHALL THE CONTRACTOR BE HELD RESPONSIBLE FOR ACTS OF VANDALISM OR NEGLIGENCE ON THE PART OF THE OWNER.

TREE PROTECTION NOTES:

1. Tree Marking

- A Prior to any tree removal or site clearing, contractor is to mark all trees to be removed with red colored ribbon, mark out proposed tree protection zones, and stake out building corners and pool location. Once staking and tree delineation outlined below is complete, notify landscape architect to arrange time and date for inspection by L.A. prior to any clearing work. Allow minimum 48 hour to schedule inspection.
- B. Trees proposed for removal are to be marked in the field with red tape. Trees to be pruned and/or limbed are to have a blue tape tied to the limb and/or area of trimming. Trees proposed for transplanting are to be be taped with numbered yellow ribbon and a stake, with a corresponding number, placed in the proposed location of transplant.

2. Establishment of a Tree Protection Zone

- A. These tree protection measures must be in place and approved by the landscape architect prior to commencement of any tree removal or cleaning.
- B. The size of the tree protection zone may be adjusted at the discretion of the Landscape Architect. The tree protection zone is determined by the size of the canopy and environmental factors not shown on the tree survey.
- C. The cleaning of equipment, storage of materials or dirt, disposal of waste material such as paint, oil solvents or other harmful substances, or any other such acts which may be harmful to the continued vitality of the tree within the tree protection zone is strictly prohibited.

3. Tree Damage

- A. Any tree damaged during construction or damage occurring as a result of such construction, shall be repaired to the satisfaction of the Landscape Architect occording to accepted International Society of Arboriculture practices. Tree damage must be repaired prior to the issuance of a Certificate of Compliance.
- B. Contractor will take all necessary precautions to insure that no trees to remain are damaged during tree removal and clearing.

4. Tree Root Protection

A. In areas where walks or paved surfaces pass through tree protection zones. The grade of these improvements shall be raised to ramp over the root zone, eliminating the need for any cutting in these areas. If fill over any root zone exceeds 40% of the root zone with depths of fill over 6" deep, then first put down min. 6" layer of graded aggregate to facilitate air and water movement through the root zone at these points. In no event shall cuts in root zones exceed 2".
