Hamilton, Tax Map No. 176-01-03-082, Located Immediately South Of 8991 State Hwy. 215 South, Jenkinsville, SC 29065. *It was moved by Council Member Marcharia; seconded by Vice Chairman Perry to approve Second Reading of Ordinance No. 613.* During discussion, Council Member Robinson asked Chairman Ferguson if he would explain to some of the individuals who spoke why the County is having to finalize the existing building and leave it. *The motion carried unanimously*.
