

MINUTES REGULAR MEETING FAIRFIELD COUNTY COUNCIL FEBRUARY 25, 2013

1. CALL TO ORDER

Chairman Ferguson called the meeting to order at 6:03 P.M.

2. APPROVAL OF AGENDA

<u>It was moved by Vice Chairman Perry; seconded by Council Member Kinley to approve the agenda. The motion carried unanimously.</u>

Council Member Kinley led in the invocation.

4. APPROVAL OF MINUTES

It was moved by Council Member Trapp; seconded by Vice Chairman Perry to approve the minutes of the work session of February 6, 2013; regular meeting of February 11, 2013 and special meeting of February 18, 2013. The motion carried unanimously.

6. PUBLIC PRESENTATIONS

Mr. John D. Henderson, Director of Risk Management Services, South Carolina Association of Counties, presented two awards to the Council: 1) Outstanding Safety Achievement Award, given for the work done in the new waste tire facility; (2) {Platinum} Award For Reporting Of Claims Quickly In Property And Liability Trust, given for averaging one half day in reporting claims. Mr. Hyatte Kelsey was asked to accept the awards on behalf of the County.

9. **BOARDS AND COMMISSIONS MINUTES**

Provided as information. Council Member Kinley commented that Carolina Adventure World was selected as the OED's Attraction of the Year and will be the submission to the State Attraction of the Year. The award will be made at the Governor's Conference on Travel and Tourism. She stated she would like to invite the representatives of Carolina Adventure World to the Council meeting to recognize them and to receive an update from them.

It was moved by Council Member Brown; seconded by Council Member Kinley to approve the Appointment listed under Section A, and the Reappointments listed under Sections A&B. The motion carried unanimously. OLD BUSINESS 11.

- A. Third and Final Reading: Ordinance No. 610 An Ordinance To Rescind the Fairfield County Uniform Solid Waste Management Ordinance, No. 410, (Also Known As "Litter Control"), Dated July 8, 2002, As Amended, and Replace It In Its Entirety With The 2012 Fairfield County Solid Waste Management Plan Update Dated April, 2012, Which Has Been Updated To Meet The Current South Carolina Department Of Health And Environmental Control (SCDHEC) Regulations And Current Fairfield County Solid Waste Handling Practices. It was moved by Council Member Brown; seconded by Council Member Trapp and Vice Chairman Perry to adopt Third and Final Reading of Ordinance No. 610. The motion carried unanimously.
- B. Third And Final Reading: Ordinance No. 611 Ordinance To Amend The Fairfield County Land Management Ordinance, Ordinance No. 596, To Provide For The Zoning Reclassification From B-2 (General Business) To RD-1 (Rural Residential), Of One (1.0) Acre, Owned By George H. Poland, Tax Map No. 119-00-03-019, Located At 177 And 179, Meadowlake Road, Blair, SC 29015. It was moved by Council Member Brown; seconded by Council Member Trapp to adopt Third and Final Reading of Ordinance No. 611. The motion carried unanimously.
- C. Third And Final Reading: Ordinance No. 612 Ordinance To Amend The Fairfield County Land Management Ordinance, Ordinance No. 596, To Provide For The Zoning Reclassification From B-2 (General Business) To RD-1 (Rural Residential), Of One (1.0) Acre, Owned By George D. Robinson, Tax Map No. 182-00-01-021, Located At 394 Hungry Hollow Road, Winnsboro, SC 29180. It was moved by Council Member Brown; seconded by Council Member Trapp and Council Member Kinley to adopt Third and Final Reading of Ordinance No. 612. The motion carried unanimously.
- D. Third And Final Reading: Ordinance No. 613 Ordinance To Amend The Fairfield County Land Management Ordinance, Ordinance No. 596, To Provide For The Zoning Reclassification From RD-1 (Rural Residential) To B-1 (Limited Business) Of Three And Seventy-Six Hundredths (3.76) Acres, Owned By Trustees For Praise And Deliverance Temple, Applicant Dr. Stuart A. Hamilton, Tax Map No. 176-01-03-082, Located Immediately South Of 8991 State Hwy. 215 South, Jenkinsville, SC 29065.

It was moved by Council Member Marcharia; seconded by Council Member Brown to adopt Third and Final Reading of Ordinance No. 613. During discussion, Council Member Marcharia brought forth that it appeared to be a lot of confusion around this particular rezoning of that land for a health center on Highway 215 South. He voiced that some of the people in his community wondered why he did not inform Dr. Hamilton about other available land. He explained the ramifications surrounding the property. Chairman Ferguson expounded on the procedures and process that transpired surrounding the property. The motion carried unanimously.
