- C. Request of Action: Economic Development Department Request to Engage Vendor DuBose Web for the Redevelopment of the County's Economic Development Website in the Bid Amount of \$29,000. We received six (6) bids from companies that were thoroughly vetted and examined. This is not a budgeted item; however, we have \$7,000.00 in the existing budget to start the project, and the remainder will fall to the next budget year to be budgeted with monthly maintenance cost of \$695.00. Motion to approve made by Council Member Robinson and seconded by Council Member Ruff. The motion carried unanimously 6-0.
- D. Request of Action: Sheriff's Department Request to Purchase 15 New Dell Latitude Rugged Laptops in the State Contract Amount of \$34,589.19. This is a State contract with budgeted amount of \$34,775.00. Motion to approve made by Council Member Ruff and seconded by Council Member Douglas. *The motion carried unanimously 6-0.*
