

MINUTES REGULAR MEETING FAIRFIELD COUNTY COUNCIL MARCH 26, 2012

1. CALL TO ORDER

Chairman Ferguson called the meeting to order at 6:10 P.M.

2. INVOCATION

Council Member Kinley led in the invocation.
