Chairman Smith called the Regular Meeting to order at 6:00 p.m.

13. COUNTY ADMINISTRATOR'S REPORT

- A. Midlands Fatherhood Coalition: Mr. Rudolph Walker gave a report on the Midlands Fatherhood Coalition. With Mr. Walker were Mr. Michael Burnside and Mr. Damon Sanders who spoke on the success of the program and the impact on their own lives. Mr. Walker also introduced Mr. Cameron Pearson who was recently hired as outreach coordinator. Council Member Ruff thanked Mr. Walker for his contributions to this program. He has enjoyed his presentations in the past with examples of lives being changed. Council Member Robinson commented that he feels Mr. Walker is doing a great job and we should get the word out better about the program. Per Mr. Walker, there are some billboards around and the program has been ongoing for 20 years now. Chairman Smith expressed his appreciation for Mr. Walker coming and sharing the information with the Council.
- **B. E-911 Upgrade:** Ms. Phyllis Watkins, Emergency Management Director, gave a report on the upgrade of the E-911 system. As of the end of January, the dispatchers have become certified emergency medical dispatchers. Ms. Watkins distributed the tablet that is now being used for incoming calls which gives prearrival instructions. Council Member Robinson asked Ms. Watkins to elaborate on the 911 text. Per Ms. Watkins, 911 is now able to accept texting; however, if a person is able to call, he or she should call. She indicated a lot of information would have to be given with the texting feature, but if an individual cannot speak, this is a good option. Chairman Smith asked about the geolocation. Ms. Watkins replied that if a call is made from a cell phone, the system will give a

cell site location but not the physical location. Chairman Smith expressed his appreciation for Ms. Watkins presenting this information to Council and he expects this will make a very big difference in the service of the department for the citizens.

16. COUNTY COUNCIL TIME

Douglas: Lake Wateree Recreation Center – The residents feel the Center was put in a location where no one would want to use it even though other locations were suggested and offered. However, anyone living in Fairfield County is welcome to use the building and the County will supply instructors for various activities. All boards in the County would be welcome to use the facility also.

Trapp: Out of courtesy to Vice Chair Goins as the District 4 representative, she will be allowed to bring information to Council before trying to make a decision on the memorial stone; however, he does not have an objection with supporting this issue.

Robinson: Commended Chairman Smith and Mr. Taylor for getting Council and the City to meet recently. With both Councils having an open mind to work together, great things can be accomplished in the County.

Smith: In reference to the memorial for Mr. Drummond in the Jenkinsville area, he has spoken with Ms. Goins and both would support relocation; however, someone should find out and let the Council know who owns the property and if they would be amenable to this request. Also, informed everyone that on Wednesday Council will be having a work session on Animal Care and Control. All interested citizens are invited to attend. Public comment will be allowed in this work session and Council would encourage folks to come and give recommendations on the existing Ordinance. Budget Work Sessions will be on the schedule soon and the Council also would like folks to come out and participate in this process. There should be a special treat at our next Council meeting with Mr. Lamar Richards present to receive a letter of congratulations. Mr. Richards, a sophomore at Fairfield Central, has just been named President of the South Carolina Senior Beta Club. In addition, Miss Natalie Green who appeared on Little Big Shots with Steve Harvey will hopefully attend a future Council meeting.

Ruff: He also saw Natalie on Little Big Shots and she is very impressive.
