D. Council Discussion

Council Members thanked everyone for coming out and participating in this work session and also for all that is done by the organizations for animals. Many useful ideas were given. Listed below are some items discussed by Council:

- Emphasis needs to be on education
- There would need to be collaboration on City/County Ordinances
- · Housing, protection from extreme elements
- Weight and length of tethers, swivel ends
- · Cruelty to animals
- · Reporting violations to the police
- Exceptions

Mr. Innes followed up stating his office has already been going into the schools to educate the children including Midlands Stem, McCrorey Liston and Geiger so far. Also, he feels Council must ensure that the County has an Ordinance the Animal Control Department can control and enforce. He asked that the Council remember a lot of the dogs on chains are in Winnsboro, which would fall under the City ordinance. Finally, Mr. Innes advised the Council to take into consideration that the counties (York and Aiken), whose ordinances have been referred to in this meeting and in the past, have a lot of help in assisting with their animals, including the Humane Society. He asked that the Council take all of this into consideration when discussing these matters.
