Third And Final Reading: Ordinance No. 561 - An Ordinance To Amend The Fairfield County Zoning Ordinance (No. 498) To Provide For The Zoning Reclassification From R-1 (Single Family Residential) To R-2 (Inclusive Residential) Of Sixty Hundredths (0.60) Acres, Owned By Quay W. McMaster, Tax Map No. 145-01-11-003.
