A. First Reading (By Title Only) - Ordinance No. 650 - Authorizing An Amendment To The Master Agreement Governing The I-77 Corridor Regional Industrial Park By And Between Richland County, South Carolina, And Fairfield County, South Carolina, To Expand The Boundaries Of The Park To Include Certain Real Property Located In Richland County; And Other Related Matters. It was moved by Vice Chairman Marcharia; seconded by Council Member Kinley to approve First Reading (By Title Only) of Ordinance No. 650. Mr. Pope gave a brief overview of the Industrial Park Agreement. **The motion carried unanimously.**

13. COUNTY ADMINISTRATOR'S REPORT AND CORRESPONDENCE

A. Strategic Plan. Contractual matter that needs to be discussed in Executive Session. Mr. Pope asked to provide a clarification regarding the Plan, which he did by citing several months back, the County embarked upon an MOU with Central Midlands Council of Governments to enter into an agreement so that the COG could assist the County with its strategic planning process. The County publicly approved the MOU with the COG; then embarked upon a process of developing an RFQ regarding the plan--looking at most planning areas of Fairfield County long term, with the exclusion of the Economic Development piece. This piece was included primarily because the I-77 Alliance is actually going through a regional strategic plan, and the County wanted to be able to piggyback off that regional data and also to be able to save some cost on our plan. Each of the four members of the I-77 Alliance (York, Chester, Fairfield, Richland) are also in the process of updating their local Economic Development Plan. The COG took the information from Fairfield County; included it in an RFQ and then it was procured and solicited. There were numerous companies that responded to that work. Before any company can work for the County, the Council has to approve that company to be able to perform those services in the RFQ. There are some contractual matters to discuss, but will come back to the County publicly before that is approved. Is there a step in this process for the citizens to give input? Is there a reason why we are using four outfits?

- **B. Phase II Commerce Park.** This was on the last agenda. Council gave authority to continue. The County has given the Notice to Proceed, and is a due diligence regarding engineering and other services at the Park. Staff has agreed to provide regular updates to the Council regarding the progress with this work. The construction part that would need to occur would come back to committee and to Council to be bid out.
- **C. Intent To Mine Applications.** It was asked at the last meeting for the County to publish any type of information that the County had received. Administration agreed to do that. There has not been any applications or any inquires made to the County from Winnsboro regarding everything else. The actual appeal period has now closed. There was a 15-day appeal period; however, the County has not received any official information for any type of site development plans or anything else. Have we done everything that we were supposed to do according to the letter of the law involving this mining process? Have our inspectors done what they are supposed to do; our legal people? Has everyone done everything that they are supposed to do--following the exact letter of the law up to this time?
- **D. Budget Update.** Council will address this via motion later in the meeting.
- **E. Meeting With Congressional Delegation.** Several items were discussed with the Delegation Liaisons. The County requested any and all assistance from members of the Delegation. The first item on the agenda was Fairfield Memorial Hospital. Gave the Delegation staff an update on how the County is trying to keep it viable and sustainable. Provided the Delegation staff with the latest information from our water and sewer consultants. Gave the staff a report on Inoperability, which is the communications system in the County and how we need to better communicate with Inter-county public agency jurisdictions to be on the same type of technology and being able to communicate with the State of South Carolina. Also discussion regarding the Fairfield County Library and construction capital costs that they are wanting to upgrade. Also mentioned Housing initiatives. The last item was a discussion regarding our postal service here in the Town of Winnsboro, where there are several ADA concerns with that facility and with the hours of operation. Will have some follow up information to be able to provide to their staff.
