

MINUTES REGULAR MEETING FAIRFIELD COUNTY COUNCIL MAY 24, 2004

1. CALL TO ORDER

The Chairman called the meeting to order at 6:00 P.M.

2. After which Council Member Kinley gave the invocation.

3. APPROVAL OF MINUTES

It was moved by Mr. Ferguson; seconded by Mrs. Robinson and Ms. Kinley to approve the minutes of the regular meeting of April 26, 2004. The motion carried unanimously.

PRESENTATIONS

Rural Transportation Plan

Mr. Wayne Shuler, Director of Planning Services, Central Midlands COG, presented the Rural Transportation Plan.

Mr. Herbert Hobgood addressed Council, *supporting* the proposed rezoning request at 2500 Syrup Mill Road

Several members of Council asked questions concerning the report of this property. Mr. Anderson gave Mr. Stowers permission to answer the questions. The following recommendations were made by Council:

When staff reports are written, so there won't be any ambiguity in the future, that the date is listed (prior to the consideration of the matter).

Though it was recognized as it not being a requirement, send courtesy letters certified, return receipt requested.

Allow citizens an opportunity to know when the Planning Commission will meet on the matter. Whatever areas can be cleaned up on the County side, Administration was charged to do so.

A. Justice and Personnel

(1). Animal Kennel. Officer has retired. The recommendation from Human Resources and the Administrator's Office is to restructure to hire an Animal Kennel Attendant, as well as a temporary, who can be there. This can be accomplished utilizing the same amount of money. So moved by Mrs. Robinson; seconded by Ms. Kinley, to approve the recommendation by Administration to the committee. The motion carried.

- A. Third And Final Reading: Ordinance No. 483 An Ordinance To Amend The Fairfield County Zoning Ordinance (Ordinance No. 335) To Provide For The Zoning Reclassification From RD (Rural Development District) To I-1 (Industrial Development District), Of A Parcel Totaling Thirty (30) Acres, Tax Map No. 213-00-00-026: Applicant Herbert G. Hobgood; Property Located At 2500 Syrup Mill Road. It was moved by Mr. Brown; seconded by Mrs. Robinson to approve Third and Final Reading of Ordinance No. 483. The motion carried 5-2. {Ms. Kinley and Mr. Ferguson voted nay}.
- **B.** Third And Final Reading: Ordinance No. 484 An Ordinance To Amend The Fairfield County Zoning Ordinance (Ordinance No. 335) To Provide For The Zoning Reclassification From RD (Rural Development District) To B-1 (Limited Business District), Of A Parcel Totaling Eleven And Twelve Hundredths (11.12) Acres, Tax Map No. 189-00-00-001, Owned By Longtown Enterprises, Located At 161 Qualls Road. It was moved by Mrs. Robinson; seconded by Mr. Brown to approve Third and Final Reading of Ordinance No. 484. The motion carried unanimously.
- C. Third And Final Reading: Ordinance No. 485 An Ordinance To Amend The Fairfield County Zoning Ordinance (Ordinance No. 335) To Provide For The Zoning Reclassification From B-2 (General Business District) To I-1 (Industrial Development District), Of Three Parcels Totaling One Hundred (100.00) Acres, Tax Map No. 035-00-00-049 And Tax Map No. 035-00-00-061 Owned By Fairfield County, And Tax Map No. 035-00-00-064 Owned By Quay McMaster, Located On S. C. State Highway 200, Just East Of The Intersection Of S. C. State Highway 200 And I-77. It was moved by Mr. Ferguson; seconded by Mrs. Robinson to approve Third and Final Reading of Ordinance No. 485. The motion carried unanimously.

It was moved by Mr. Marcharia; seconded by Mr. Ferguson that Council appropriate the necessary funding for the motion of the restrictors and the necessary improvement to the line on those projects that were brought forth, along with any other projects that Council has dealing with restrictors in situations similar to this one. Mr. Ferguson inquired if he might be able to attend the meeting. The motion carried unanimously.

12. PUBLIC COMMENT

Mr. Troy Carpenter spoke to Council concerning the rezoning matter that was handled earlier. The following individuals signed, but were not present to speak during public comment: Mr. Harry Gurganious, Ms. Ruchelle Gee, Mr. Herb Hobgood.

13. COUNTY COUNCIL TIME

Brown: Commented on a matter that appeared in the Zoning Board of Appeals minutes pertaining to a request for a variance.

Kinley: Inquired of the status of changes on the Zoning Ordinance. This matter was assigned to the Economic Development Committee. Also, mentioned the manager of Walmart is purchasing a home in Winnsboro. Also mentioned that Todd Robinson is assistant head coach in Mauldin, and they won the state championship in baseball.

Robinson: Inquired about when Council will begin the budget process. Commented about the concerns during public hearing dealing with traffic at the flashing lights. Inquired about the reapplication of 4-way stop lights at the rubbles.

Murphy: Maintained that property in the future is posted on the edge on the road as close of possible on the property and access to the property (that it is posted in a conspicuous place). Pointed out that the official position of Council is that Mr. Stowers properly posted the property. It was moved by Mr. Brown; seconded by the remaining members of Council to have Administration look at possibly securing a tar truck, along with having Public Works look at the feasibility of it, and bring a recommendation back to Council. The motion carried unanimously.

Trapp: Inquired about the minimum width of water lines for fire protection.

Marcharia: "Have a sense or feeling that the Council is beginning to move strategically toward thinking about the fire and safety and the possibility that these type of decisions will foster the kind of infrastructure that will stabilize the communities with small businesses. Big industries come and go, but it more strategic to have small businesses. The Council is moving toward that direction. I think it is a very wise move and to stabilize our community. I appreciate this."

Ferguson: Talked about the fire board's presentation dealing with the

problems in getting volunteers, and suggested that they come up with a different proposal of rewarding the firefighters to go to fires. This matter was referred to the Environmental and Public Safety.
