1. CALL TO ORDER

Chairman Ferguson called the meeting to order at 6:01 P.M.

2. APPROVAL OF AGENDA

It was moved by Council Member Robinson; seconded by Council Member Marcharia to approve the agenda. **The motion carried unanimously.**

The motion carried 5-1. {Council Member Brown abstained from voting and so notified the Chairman at the beginning of the meeting by signing a statement of potential conflict of interest form, which is on file in the Clerk to Council's office}.
- **E. First Reading (By Title Only): Ordinance No. 637** An Ordinance Authorizing Fairfield County To Purchase Land Known As Rufus Belton Park For Recreational Uses And Location Of Emergency Personnel And Services, Being A Portion Of Fairfield County Tax Map Number 152-00-00-037. It was moved by Council Member Robinson; seconded by Vice Chairman Perry to approve First Reading (By Title Only) of Ordinance No. 637. The motion carried unanimously.
- F. First Reading (By Title Only): Ordinance No. 638 An Ordinance Authorizing Fairfield County To Sell And Convey County-Owned Property Located Off Of Center Creek Road, Containing Four Hundred And Five Acres, More Or Less, By Private Sale, Being Shown On The Fairfield County Tax Maps As Parcel Number 201-00-01-111. {Chairman Ferguson set forth that he received a statement of Conflict of Interest from Council Member Brown as it relates to Ordinance No. 638}. It was moved by Vice Chairman Perry; seconded by Council Member Robinson to approve First Reading (By Title Only) of Ordinance No. 638. The motion carried 5-1. {Council Member Brown abstained from voting and so notified the Chairman at the beginning of the meeting by signing a statement of potential conflict of interest form, which is on file in the Clerk to Council's office}.

10. BOARDS AND COMMISSIONS APPOINTMENTS

It was moved by Council Member Marcharia; seconded by Vice Chairman Perry to approve the Re-Appointment Ratification as presented for the Fairfield Memorial Hospital Board. **The motion carried unanimously.**

12. NEW BUSINESS

A. Procurement Policy Approval - Committee Recommendation

Mr. Pope prefaced the discussing saying this is a document that staff brought to the committee. The committee met several times, going through the document section by section. Mr. Pope pointed out one item in the draft on page 49 and the top of page 50: Staff is requesting Council's indulgence to add the following language that the committee did not see: C. Duty of Contractor: In order that the inspection services of the governing local building official may be made available for construction, plumbing, heating, air conditioning, and electrical work, the contractor shall obtain and require that each of its subcontractors, for these specialty contracts, apply for, obtain, and pay any applicable cost of all required permits and inspections fees for the specialty for which he is subcontractor. This language, Mr. Pope said, was added in due to what staff thought would be an improvement in the process. Staff is asking for Council to amend and include this in the consideration of the amended Procurement Policy. It was moved by Council Member Brown; seconded by Council Member Kinley to add the change as prescribed. {Council Member Robinson respectfully requested that Council not vote on this tonight; that it be postponed until the next regular scheduled meeting, so that it can be reviewed a little more \}.

Subsequently, Council Member Kinley withdrew her second to the motion; Council Member Brown withdrew the motion from the floor. Chairman Ferguson set forth that this matter will be brought back at the next meeting.

13. COUNTY ADMINISTRATOR'S REPORT:

- A. County Spotlight. Fairfield Animal Services Mr. David L. Brown
- **B.** <u>Drawdy Park Update.</u> Waiting on the final engineering report. Should be activity at Drawdy Park this week after the final reports are received by the County and signed off by the third party inspector.
- **C.** <u>Fairfield County Alert Site Update.</u> For the sake of time, deferred until the next meeting.
- **D.** <u>Discretionary Funds Policy Update.</u> Staff is prepared to present its recommendations to committee before the next Council meeting.
- **E.** Request Of Action: Replace Wrecked 2008 Ford Crown Victoria Sheriff's Office Patrol Vehicle. The 2008 vehicle was totaled in an accident. After the insurance settled, the County received \$6,500.00 from the insurance company. The Chevrolet Caprice, under state contract, is \$26,700.00, which is actually over the \$25,000.00; however, the package that goes along with that (light bars, etc.) is \$10,612.00. The total, after

reduction of the insurance, is \$31,107.47. Asking for Council's favorable approval. It was moved by Vice Chairman Perry; seconded by Council Member Kinley to approve the replacement of the wrecked 2008 Ford Crown Victoria Sheriff's Office Patrol Vehicle. **The motion carried unanimously.**

- **F.** Request Of Action: Capital Request Approval For Public Works Trailer. Administrator is asking that this item be deferred until the next Council meeting. Staff will be looking at some additional cost savings to bring that within budget.
- **G.** Fire Service Equipment (Requesting Approval of Overage). Several pieces of fire equipment was ordered (in lots) in order to get the best pricing. The lowest responsive bidder came in about \$2,700.00 over the \$25,000.00 amount. In order to stay consistent with the policy, Administration desires Council's approval to move forward with the overage. It was moved by Vice Chairman Perry; seconded by Council Member Brown to approve the overage as set forth. **The motion carried unanimously.**
- **H.** Elliott Davis, LLC Contract Renewal. This matter was actually approved through funding; however, Administration wishes for it to be publicly approved. Asking Council's consideration to extend the auditing contract for Elliott Davis with the County for a three-year period. It is very important that the County does not experience an interruption of auditing services, and Elliott Davis is very familiar with the County's books. It was moved by Council Member Marcharia; seconded by Council Member Kinley to renew the auditing contract with Elliott Davis for three years. **The motion carried unanimously.**
- **I.** Proposed Purchase/Sale Of Property Update. Potential Executive Session item. Have worked with our County Attorney on Items D, E, and F under Section 8. These are By Title Only, and by Second Reading, should have the information with pricing. Some of that information is still being negotiated for finalization; however, all pricing and ownership must be made public before the local government purchases or sells property in its inventory. This is a placeholder in the event Council has any questions.
- **J.** <u>Economic Development Update.</u> This is to give Council an update on a pending economic development potential project.
- **K.** <u>Legal Advice On Industrial Park Easement.</u> Thought this matter was finalized; however, our Attorneys have advised there is a new issue that has arisen with this that the Council needs to be made aware of.
- **L.** <u>Personnel Matter.</u> Regarding a County Elected Official that the Council is to receive an update on.
