6. NEW BUSINESS:

A. First Reading (By Title Only) – An Ordinance To Develop A Jointly Owned And Operated Industrial/Business Park In Conjunction With Kershaw County, Phase II Target Corporation, Such Industrial/Business Park To Be Geographically Located In Fairfield County And Kershaw And Established Pursuant To South Carolina Code Of Laws Of 1976, Section 4-1-170, Et Sequitur, As Amended; To Provide For A Written Agreement With Kershaw County Providing For The Expenses Of The Park, The Percentage Of Revenue Application, And The Distribution Of Fees In Lieu Of Ad Valorem Taxes To The Counties And Relevant Taxing Entities; And To Provide That Jobs Tax Credits Allowed By Law Be Provided For Industries Locating In Said Park, And To Permit A User Fee In Lieu Of Ad Valorem Taxation.

B. First Reading (By Title Only) – An Ordinance To Suspend The Application Of Sunday Work Prohibitions Provided In Chapter 1 Of Title 53 Of The Code Of Laws Of South Carolina, 1976, As Amended, For August 4, 2002; To Provide That Any Employee Of A Business Which Operates On Sunday, August 4, 2002 Has The Option Of Refusing To Work Who Is Conscientiously Opposed To Sunday Work; And to Provide For Other Matters Relating Thereto.

C. First Reading (By Title Only) – An Ordinance To Amend Section 9.7 Extending The Time For System Upgrade Of The Existing Cablevision Franchise Ordinance Between Winnsboro/Ridgeway Cablevision, Inc. And The County Of Fairfield, Dated April 9, 2001.
