

MINUTES WORKSESSION FAIRFIELD COUNTY COUNCIL SEPTEMBER 7, 2011

In accordance with the South Carolina Code of Laws, 1976, Section 30-4-80 (e), as amended, the following persons and/or organizations have been notified of the time, date, and location of this meeting: The <u>Herald-Independent</u>, <u>The State</u>, and Winnsboro Cablevision, and fifty-three other individuals.

1. CALL TO ORDER

Chairman Ferguson called the meeting to order at 6:20 P.M.

2. INVOCATION

Council Member Kinley led in the invocation.

3. ITEMS FOR DISCUSSION

A. Executive Session: Receive Legal Advice

At 6:22 P.M., it was moved by Council Member Kinley; seconded by Council Member Marcharia, to go in executive session to receive legal advice. The motion carried unanimously.

At 6:48 P.M., it was moved by Council Member Kinley; seconded by Council Member Robinson to come out of executive session and return to regular session. The motion carried unanimously.

Chairman Ferguson reported the Council received legal advice.

6:49 P.M. {Council recessed}.
7:40 P.M. {Council returned from recess}.

B. Criteria For Developing Plans For The 2010 Redistricting Process

Council began the redistricting discussion.

Mr. Gilbert made the following presentation and comments:

- Pulled up the plan that was discussed at the last meeting, which was about 80% completed.
- District 1 and District 7 need the most in terms of correcting the deviation.
- As of August 29, Plan 2 had: District 1 (+3.45%), District 2 (-.09%), District 3 (-.18%), District 4 (+2.48%); District 5 (+.06%), District 6 (-1.29%), District 7 (-4.38%).
- Plan 2: Showed census figures; overlay shows top number (total persons in the block); bottom number represents the number of African Americans in the block.
- For approximately two and one half hours, each member of Council asked questions and made comments about the figures in their respective districts. Mr. Gilbert explained the benchmark figures; worked one-on-one with each member of Council, answering their questions and making certain recommendations with them that would meet Justice Department approval.
- The Chairman commented that the School Board has asked that Council have a brief meeting with them before it is finalized. He solicited comments from the Council about the request.

- Suggestions: (a) if the Council comes up with an agreement tonight, ask Mr. Gilbert to run two (2) copies of the maps (by districts); take one set to the School District for each School Board member; if there are any drastic concerns, Council could scheduled another meeting; (b) give the maps to the School Board and indicate that they are nearly complete; (c) if the School Board comes back and say they still want to have a meeting, it would be incumbent upon Council to have a meeting with them; (c) to see the ORS staff move the territories around is so much more valuable than someone just given paper.
- At this point, Mr. Gilbert presented the map and statistics, by district, with the changes as discussed tonight:

District 5	3,424	0.06%	66.85%	61.55%
District 6	3,419	-0.09%	60.19%	55.98%
District 7	3,408	-0.41%	55.96%	52.46%

- This plan has minimal retrogression and meets all the legal deviation requirements.
- It was moved by Council Member Brown to accept Plan 2.
- Chairman Ferguson pointed out that second reading will be held on September 12, 2011 and third and final reading and public hearing will be held on September 26, 2011.
- Council Member Brown withdrew his motion.

4. ADJOURN

The meeting was adjourned at 10:15 P.M., upon unanimous approval of County Council.
