- III. Ordinance No. 799:** An Ordinance to Appropriate General Fund Revenues for the Hiring of Three (3) New Officers for the Fairfield County Detention Center and to Increase the Bonus for Newly Certified Detention Center Officers from One Thousand Dollars (\$1,000) to One Thousand Five Hundred Dollars (\$1,500).
- IV. Ordinance No. 800:** An Ordinance to Appropriate General Fund Revenues in the Amount of \$486,535.79 to Provide Cost of Living Increases of Two Percent (2%), Three Percent (3%), or Four Percent (4%), as Applicable, to the Base Salaries for All County Employees and; \$100,000 Increase the Operating Budget of the Sheriff's Department for the Purpose of Additional Salary Adjustments within the Department; and \$20,000, to Provide Incentive Bonuses to Volunteer Firefighters who Meet the Requirements of the Volunteer Incentive Program Administered by the Office of State Fire Marshal.
- V. Ordinance No. 802:** An Ordinance to Appropriate General Fund Revenues in the Amount of \$363,000 to Provide Supplemental Funding for the River Road Fire Station Project.
- VI. Resolution No. 2022-08:** A Resolution to Transfer Approved Dominion Settlement Agreement Funds From the Fairfield Commerce Center Parcel 9 Mass Grading Project which are In Excess of the Funds Needed for that Project, to Provide \$400,000 in Additional Funding needed for the Construction of The Ridgeway Community Center because of Post Covid Construction Cost Inflation.
