We, the undersigned property owners with land adjoining the above referenced street/road, do hereby petition Fairfield County to accept this private road into the County Road System for scheduled maintenance and repair. We have read Fairfield County Policy and Road Ordinance #820 and understand that:

1. It is the applicant's responsibility to have One Hundred Percent (100%) of the owners of property which adjoins the right-of-way to agree to the application, dedicate the right-of-way to the county, dedicate drainage easements and remove utilities, fences, gate post, etc.; in order for it to be presented to the Public Works Department for consideration.
  
2. After consideration, this application will be presented to Fairfield County Council and if it is accepted we will be required to grant the County a 50' wide right-of-way, including the existing roadway and whatever additional land is required to assemble a 50' right-of-way, and existing or proposed drainage easements necessary for adequate drainage. A lesser right-of-way may be considered if it can be demonstrated that it is not feasible to assemble a full 50' right-of-way; In lieu of the minimum right of way, landowners could provide a combination of dedicated right of way and drainage and/or road improvement easements. By signing below, we hereby agree to do so.
  
3. We also understand the road will be designated for public use.
