

# MINUTES INAUGURATION & ORGANIZATION MEETING JANUARY 9, 2023 5:00PM

#### 1. CALL TO ORDER

# 2. ELECTION OF OFFICERS

Deputy County Administrator Synithia Williams informed the Council that there were ballots placed in front of them. She said they would start by voting on the Chair of Council first and then the Vice Chair. She asked them to fold their ballots in half after they cast their vote and Dr. Roberts would collect the votes. The two of them would leave the dais to count the votes and would return to announce the results. After the votes were collected and tallied, she announced Douglas Pauley as the new Chair and Clarence Gilbert as Vice Chair – both were unanimous.
