III. New Business: Rezoning Request - Buckeye Enterprises LLC

Staff presented a detailed staff report on behalf of an applicant requesting to rezone approximately 4.44 acres from RC (Rural Community District) to B2 (General Business District). Said property is an existing storage unit business. The applicant wished to expand the storage units by adding on additional dry storage bays. As zoned the applicant was restrained by density, not use, whereby limiting the applicant from gaining max use of the business parcel. Staff's recommendation was to approve the rezone request. The Planning Commission made a unanimous recommendation to County Council to approve the rezone request. Motion passed 4-0.

V. Old Business: Comprehensive Plan Work Session #5

Gregory Sprouse returned to update the Planning Commission on the Comprehensive Plan and walked them through where he and staff have been to date. Representatives from the Town of Winnsboro and Ridgeway were present to share their views, plans and updates of their specific jurisdictions. Gregory had met with representation from Jenkinsville prior to the meeting, and these discussions will be implemented into the plan document where applicable. Some of those items will be water/sewer plans that the Town of Winnsboro has in place and coordinating the Land Management Plan around those areas with focus on development types and goals. Same goes for Ridgway where they have a lot of focus on enviro-tourism and the plans set for the Hwy 21 corridor. Discussion there was focused on preserving the natural areas along the Hwy 21 corridor and limiting things like signage etc. Jenkinsville representative Mayor Guinyard has focus on County-Wide housing study and what the market may support. Gregory and Staff discussed with the Planning Commission how they will utilize these new elements for the Comp Plan and how it can help guide growth for Fairfield for the next 10 years. The discussion concluded with questions and clarifications from the Planning Commission and Gregory stated that a draft of the Comp Plan is slated for the first of September.
