

### MINUTES REGULAR MEETING FAIRFIELD COUNTY COUNCIL MAY 11, 2020

Due to COVID-19 (Coronavirus), the meeting is being live-streamed through the County's YouTube page in order to keep citizens informed.

#### 1. CALL TO ORDER

Chairman Robinson called the Regular Meeting to order at 6:04 p.m. Council Member Douglas and Council Member Trapp joined by phone.

### 2. APPROVAL OF AGENDA

Motion made by Council Member Douglas and Council Member Bell, seconded by Vice Chair Goins, to approve the Agenda. *The motion carried unanimously 6-0 with Council Members Douglas and Trapp voting by phone (Council Member Gilbert had not yet arrived at the meeting).* 

#### 3. INVOCATION

Council Member Douglas led the invocation.

#### 4. APPROVAL OF MINUTES

It was moved by Council Member Pauley, seconded by Vice Chair Goins, to approve the Budget Work Session minutes of April 22, 2020, and the Regular Meeting minutes of April 27, 2020. *The motion carried unanimously 6-0.* 

#### 5. PUBLIC PRESENTATIONS

A. Proclamation in Remembrance of Sheriff Herman W. Young. Proclamation has been prepared, and Chairman Robinson wanted to give Council an opportunity to say a few words. He stated he worked for Sheriff Young for 12-13 years, and he always gave great advice. To the family, Sheriff Young will be missed, and he left a great mark in the County. Council Member Bell served as the Chairman of the Board for the Sheriff's Success Academy for about four years. This was a program to work with underprivileged youth, which was one of Sheriff Young's visions for the County. Council Member Pauley stated he worked for Sheriff Young for about 14 years, and he was a great Sheriff and a great man. He did a lot for Fairfield County. Also, Council Member Pauley wanted to mention Marion Robinson, who also recently passed away. He is currently in the seat held by Mr. Robinson. He also was a great man and always had a good word for Fairfield County. He offered prayers for Mr. Robinson's family as well as Sheriff Young's family. In addition, Mrs. Harriett Albert passed away, who was a former 911 dispatcher. She was a great dispatcher and worked a long time for the County. Prayers were also offered for her family. Council Member Gilbert arrived at 6:08 p.m. He offered his condolences to Sheriff Young's family. He was a super quy and an inspiration. His death is a big loss to the County, and he was a model in the County and will be missed. Vice Chair Goins sends her condolences to the family. She did not have a personal contact with the Sheriff, but she knows his reputation which preceded him. She thanks God for his labor of love to the community. Also, to Mr. Robinson's family, she did get to know him personally and considered him to be a true friend. Her thoughts and prayers are with the family.

#### 6. PUBLIC HEARINGS

#### 7. ORDINANCES, RESOLUTIONS AND ORDERS

A. Second Reading Ordinance No. 741: An Ordinance to Establish Operating and Capital Budgets for the Operation of the County Government of Fairfield County for the Fiscal Year Commencing July 1, 2020; to Provide for the Levy of Taxes for Fairfield County for the Fiscal Year Commencing July 1, 2020, to Provide for the Expenditure of Tax Revenues and Other County Funds; to Provide for Other County Purposes; to Provide for Certain Fiscal and Other Matters Relating to County Government; and Other Matters Related Thereto. Motion made by Vice Chair Goins, seconded by Council Member Gilbert, to approve Second Reading of Ordinance No. 741. Chairman Robinson stated the amendments to the

budget must be voted on, and requested Mr. Morgan to explain. Per Mr. Morgan, at this point it would require a motion to amend, and at the conclusion of all the proposed amendments, then Council will need to entertain a motion to approve the budget ordinance as amended, thereby incorporating all of the individual amendments to the ordinance at that time.

- Recreation Sports Fee: Council Member Pauley made a motion to remove this item from the motions list, seconded by Council Member Gilbert. Mr. Pauley stated the director had to credit everyone for the spring sports because of the Coronavirus. It was, therefore, in the department's best interest to hold this request until next year. *Motion carried 7-0.*
- Fire Service Fees: Council Member Bell made a motion to amend the budget to include the fire service fees, seconded by Council Member Gilbert. *Motion carried 7-0.*
- Fee Schedule: Council Member Gilbert made a motion to amend the budget to add the fee schedule, seconded by Vice Chair Goins.
   Per Mrs. Bass, the additions are highlighted in yellow. *Motion* carried 7-0.
- Hourly rate increase based on tier structure: Council Member Bell made a motion to amend the budget to include option 3 - reduce >\$50,000 to 1% and implement January 1, 2021 (6 months), seconded by Council Member Gilbert. Council Member Pauley inquired if each Council member would make their own motion, or vote against, etc. Per Mr. Morgan, any Council Member can make an amendment to the amendment or allow this to go forward on option 3. Should it pass, then the only way another motion could be brought would be a motion to reconsider if you were on the Chairman Robinson asked for Mr. winning or prevailing side. Caulder to give further information. Per Mr. Caulder, taking the greater than \$50,000 a year employees down from 1.5 to 1 would come out to be right at a 2 or 2.5 increase overall financially. The structure is set up to avoid compression, which means the lower paid employees could potentially pass the higher classified jobs. Council Member Douglas inquired if a raise must be given every year. Council Member Pauley agrees. Two years a merit-based raise was given, last year was a cost of living raise, and there is a Chairman Robinson inquired of Mr. budget shortfall this year. Caulder if this would get the lower paid employees up to par, and per Mr. Caulder, it would get the County competitive. Per Mrs. Bass, the tiers are designed as follows: less than \$30,000 would

be a 6% increase, \$30,000 to \$40,000 would be a 4% increase, \$40,000 to \$50,000 would be a 2.5 increase and then the greater than \$50,000 originally was 1.5 but option 3 would be to take this group down to 1%. Also, a second part of the option was to implement the whole system effective January 1 rather than July 1. In the past, 2 or 3% cost of living has been given across the board. Council Member Douglas inquired who the County is competing with. Per Mr. Taylor, the County is competing to get employees. Job advertisements are being listed, and there is no response to many of them. Chairman Robinson attempted to take a vote, and apparently Mr. Douglas and Mr. Trapp were no longer on the line. It was determined the call had been dropped.

Recess taken at 6:27 p.m. to deal with audio problems. Member Douglas was able to dial back into the meeting; however, Mr. Trapp could not be reached. At 6:34 p.m., the meeting resumed.

Per Mr. Morgan, a vote has been called to the motion on the table; therefore, there can be no other amendments. The options available at this time are to vote yes in favor of option 3 under item 4 or nay as it relates to option 3. However, Mr. Morgan stated due to the unusual circumstances and the fact that a Council Member attending by phone and during the pendency of discussion, while it was going on, the phone call cut off, that could have closed the door on any potential motions to amend. Going forward now with the vote may cut off any possibility to make a motion to amend. At this point, it cannot be ascertained who heard what. All of Council needs to have their right to get their vote in. Therefore, let's back this out of the vote, and if anyone wants to continue the discussion about option 3 or make further amendments, this can be done and we can work our way back. This would be the fairest way to handle this. Council Member Pauley then repeated his statement that he did not feel the County needs to do the tier at this time because two years ago there was a merit based raise given and last year there was a cost of living raise. With having a budget shortfall this year, this would not be the year to do the tier program. Council Member Pauley then made an amended motion to not do the tier system this year, seconded by Council Member The motion failed 2-4 with Council Member Bell, Council Member Gilbert, Vice Chair Goins and Chairman Robinson voting nay. Going back to the original amending motion, Chairman Robinson then called for the vote for option 3.

# Motion carried 4-2 with Council Members Pauley and Douglas voting nay.

- Council Member Pauley made a motion that Longevity: longevity would be five years or longer employed with the County, seconded by Council Member Douglas. Council Member Bell made a motion to amend to include option 4, seconded by Council Member Pauley. Motion failed 2-4 with Council Member Pauley, Council Member Gilbert, Vice Chair Goins and Chairman Robinson voting nay. Returning to the original amending motion, Chairman Robinson then called for the vote for option 3 for employees who have been with the County five years or longer. **Motion passed 6-0.** Member Pauley inquired if the current longevity policy would need to be amended. Per Mr. Taylor, this will be brought back to Council.
- Recycling Attendant Pay Increase: Motion made by Council Member Douglas for the recycling attendant pay increase option 2, seconded by Council Member Bell. Council Member Gilbert wished to make an amendment and inquired if they would be included in the tier. Chairman Robinson stated they would not be included in the tier. Council Member Gilbert then withdrew his amendment. Council Member Pauley made an amendment to the motion to move forward with option 3 because they just received an increase recently, seconded by Council Member Chairman Robinson agreed that an increase was recently done, and this would be singling out one department. Council Member Bell made an amendment to the motion to include all temporary or part-time employees not included in the tier system be given a 0.30 per hour raise. Council Member Pauley inquired how this could be voted on when the cost impact is not known. Motion died for lack of a second. Council Member Bell then made an amendment to go to option 1 for 0.50 per hour. Motion died for lack of a second. Chairman Robinson then called for the vote on the original amendment. Motion carried 5-1 with Council Member Bell voting nay. Mr. Morgan stated this was an amendment to an amendment, now we must go back to the original. Option 3 passed with a 5-1 vote, but this was amending the option 2. Now we need a vote to approve as amended, which would be the option 3 selection. Council Member Gilbert made a motion to approve as amended, seconded by Vice Chair Goins and

# Council Member Pauley. *Motion carried 5-1 with Council Member Bell voting nay.*

- Veteran's Day. This item failed for lack of a motion.
- Tax Auditor Position Request: Council Member Gilbert made a motion to amend the budget to add the tax auditor position request, seconded by Council Member Pauley. Per Mr. Caulder, this would be providing clerical support for the tax auditor's office. There are two employees currently in this office and only one of a couple of departments with only two employees. There is a concern for risk of losing a lot of knowledge and experience. This will give the auditor an opportunity to provide a good bit more training to the person currently in the office and allow them to not have to close the office altogether if someone is out. Also, there are some additional state requirements and changes in laws that have made the work load more difficult for two people to manage. Council Member Bell stated this is not currently in the budget and would add another \$40,000 to the Motion carried 5-1 with Council Member Bell voting nay. Council Member Bell stated the salary and fringe is 57% of the budget.
- Tax Assessor Position Request: Motion made by Council Member Pauley to amend the budget to add the tax assessor position request, seconded by Vice Chair Goins. Mr. Hensley was present in the Chamber and stated he is looking to replace a temporary position and make it a FT position to allow that person to do more and to be an appraiser. There are currently three appraisers, including Mr. Hensley. The other two are split with GIS and Forfeited Land Commission, which is taking up a lot of their time. Council Member Pauley inquired the number of employees in the department. Per Mr. Hensley, he has 4 FT employees and one temporary. Council Member Bell inquired if another office could take over the Forfeited Land Commission. Council Member Douglas would just replace the part-time person. Mr. Caulder stated the office is two people short from Discussion ensued pertaining to the where they were. employee splitting time with the Forfeited Land Commission. Motion carried 4-2 with Council Members Bell and Douglas voting nay.
- Code Enforcement Position: Motion made by Council Member Pauley to amend the budget to add a part-time code enforcement position, seconded by Council Member Douglas. Council Member Bell amended the motion to be as stated a FT

position, seconded by Council Member Gilbert. Vice Chair Goins inquired if a part-time person would be sufficient. Discussion ensued. Motion carried 4-2 with Council Members Pauley and Douglas voting nay. Council Member Gilbert then made a motion to accept the amended motion as is, seconded by Council Member Bell. Motion carried 4-2 with Council Members Pauley and Douglas voting nay.

- Detention Center Kitchen Supervisor: This item failed for lack of a motion.
- Ridgeway Community Center: Council Member Bell made a motion to amend the budget to add \$400,000 to begin the work for a community recreation center in District 1. Motion died for lack of a second.
- Food Bank: Council Member Gilbert made a motion to remove this item from the motions list, seconded by Council Member Pauley. Motion carried 6-0.
- Council Member Bell made a motion to Behavioral Health: amend the budget to allocate \$26,500 for Behavioral Health, seconded by Council Member Gilbert. Council Member Pauley questioned if he should recuse himself since he is on the board. Per Mr. Morgan, it probably would be best that he be recused. Council Member Pauley recused himself from the vote (see attached). Chairman Robinson believes Behavioral Health is a great entity, and asked Council to keep in mind there are budget cuts being made in the County. Vice Chair Goins inquired if there was an explanation for the additional money Per Mr. Taylor, this would primarily be for housekeeping and grounds keeping. Per Mrs. Johnson, originally it was a \$56,000 increase, \$26,000 for janitorial services and supplies and another \$30,000 to reimburse for substance abuse treatment services for uninsured underinsured people. Council Member Gilbert stated he had a conversation with Mr. Kennedy, and he stated this request was based on the fact that, before the new building was built, the County had promised to take care of the maintenance and the housekeeping. This service was then pulled from under them without notice thereof, which has been a strain on their budget to try to keep up with this. Mrs. Johnson stated she sent an email to Behavioral Health back in July stating these services would be discontinued. She found out that the inmates were cleaning the building and building maintenance was cutting the Inmates are not supposed to go onto non County

- property, and building maintenance has to keep up the County buildings. *Motion failed 2-3 with Council Member Douglas, Vice Chair Goins and Chairman Robinson voting nay.*
- Chameleon Inspirations Learning Center: Vice Chair Goins made a motion to amend the budget and remove this item. Motion failed for lack of a second. Council Member Bell made a motion to amend the budget by the addition of \$4,000 for Chameleon Learning Center. Chairman Robinson stated a motion would not be needed since the motion failed to remove the item. Council Member Bell withdrew his motion. Council Member Gilbert seconded the motion. Council Member Pauley requested for further information as to whether this is a for profit or non profit organization. Per Mrs. Johnson, according to their packet, they are a 501(c)(3). They have been getting funding from the County for several years. They used to have a grant, and the County was helping to supplement the grant. The grant was only for a certain number of years. Council Member Pauley inquired if they are currently paying rent for their building. According to the packet, Mrs. Johnson stated they are not asking for any type of rent. Vice Chair Goins inquired how many students attend. This information is not in the packet, but it does include after school and summer programs pre-K through 6<sup>th</sup> grade. Council Member Bell stated the budget represents the Council. Vice Chair Goins stated it also helps support the children. Mr. Morgan further explained this item, and Council Member Gilbert withdrew his second and Mrs. Goins withdrew her motion, thereby leaving this item in the budget. Council Member Douglas made a motion to amend the budget by removing the allocation for this item. **Motion failed** for lack of a second.
- Community Development Dodge Ram Extended Cab 4x4 (2): This item failed for lack of a motion.
- Fire 250 Truck 4x4 with Service Body: Council Member Gilbert made a motion to amend the budget to add the truck for the fire service, seconded by Vice Chair Goins. Council Member Pauley inquired if the training officer was approved, and this was approved. Council Member Douglas asked what vehicle was being driven at this time. Per Mr. Pope, this is a temporary employee, and they are not assigned a vehicle at this time. Council Member Bell inquired if hours would be added to the inspection employee. Per Mr. Taylor, it will be gauged first to see how much will be received from the fees, and then this will

be revisited in the future. Council Member Bell stated the added hours could be taken up by the fees. **Motion carried 6-0.** 

Sheriff's Department – 9 vehicles: Council Member Gilbert made a motion to amend the budget to include three vehicles, seconded by Vice Chair Goins. Council Member Bell made a motion to amend to add three additional cars to make a total of six vehicles. Motion failed for lack of a second. Council Member Bell then made a motion to amend to add two additional cars to make a total of 5 vehicles. Motion failed for lack of a second. Council Member Bell then made a motion to amend to add one additional car to make a total of 4 vehicles, seconded by Council Member Pauley. Council Member Pauley inquired of Sheriff Montgomery how many vehicles he is down and whether or not the wrecked vehicles are being replaced by insurance. If so, will this take away from the nine that are being requested. Per Sheriff Montgomery, that has nothing to do with the nine that are being requested. Motion failed 4-2 with Council Member Gilbert, Council Member Douglas, Vice Chair Goins and Chairman Robinson voting nay. Chairman Robinson then called for the vote on the original amendment of three vehicles. Motion carried 4-2 with Council Members Bell and Pauley voting nay. Montgomery inquired if he could get three more offices at the new admin building as he will need to have more deputies inside the office if he cannot put them on the road in vehicles. Per Mr. Taylor and Chairman Robinson, the plans can be looked at to see. Sheriff Montgomery stated if not, maybe another building can be utilized for the Sheriff's office.

Per Mr. Taylor, with some vehicles not being approved, this will leave no vehicles to shuffle. Council Member Pauley questioned the vehicle transfer system. Per Mrs. Johnson, the departments in this instance don't usually get vehicles passed down. Community Development was requesting 4-wheel drives and currently has 2-wheel drives, so the other two departments could use the 2-wheel drives. If at all possible, vehicles are transferred to other departments that can use them instead of sending to auction and buying new vehicles. Council Member Douglas inquired what the departments are driving now. Per Mr. Caulder, the public works supervisor is driving a 2-door Colorado with not enough room to carry tools, supplies, etc.

The other supervisor vehicle in solid waste has already had the engine replaced and has near 300,000 miles. Mr. Taylor stated administration will make the needed decisions concerning the vehicles. Council Member Bell made a motion to accept the amended budget ordinance with also adding the recreation building to District 1. Motion failed for lack of a second. Council Member Gilbert made a motion to accept the amended budget ordinance, seconded by Vice Chair Goins. Council Member Bell made a motion to amend the amended motion to add \$300,000 to begin the work for District 1 for a recreation community center. Motion failed for lack of a second. Chairman Robinson called for the vote on the motion to accept the amended budget ordinance. Motion passed 5-1 with Council Member Bell voting nay.

**B.** Second Reading Ordinance No. 748: An Ordinance Authorizing Fairfield County to Purchase Certain Real Property in Fairfield County, South Carolina; Authorizing the Execution and Delivery of a Purchase Agreement, an Option Agreement and a Right of First Refusal Agreement; Authorizing the Expenditure of Certain Grant Funds; and Other Related Matters. #### 11. NEW BUSINESS

A. Ad Hoc Committee for the Purpose of Exploring Local Economic Business Assistance. Per Mr. Taylor, there are some counties that are forming economic assistance programs for their local downtown businesses. The Chamber of Commerce has requested the County consider something. There are no recommendations at the present time, but instead to set up a committee to look at what might be appropriate for the County to do,

and then bring this back to Council. Council Member Douglas suggested to have members from the Town and the County and possibly Ridgeway. Per Mr. Taylor, the Chairman has the authority to form Ad Hoc Committees. Per Mr. Morgan, there needs to be an establishment of what the committee will study to be sure this is clear on the record, and the committee will need to make a recommendation within 60 days. Council Member Bell questioned the need to have a motion and vote, and per Mr. Morgan, the Chairman has the authority to form the Committee, but what the committee will study needs to be clearly on the record. Council Member Bell made a motion, seconded by Council Member Gilbert, to look into this matter for the Fairfield County businesses. *Motion carried 6-0.*

#### 14. COUNTY COUNCIL TIME

Bell: Council Member Bell wished to read part of a letter from Senator Tim Scott to the Secretary of the Department of Health and Human Services. There was a study done by George Washington University and Howard University discussing underlying health conditions. This study looked into what causes the underlying conditions. One cause is environmental pollution, which consists of dumps in poor and African American neighborhoods, smoke, incinerators, dust, power lines, etc. The second cause is not enough healthcare, not enough physical activities and facilities in poor black and impoverished neighborhoods. Tonight, Council Member Bell was trying to get a community recreation center for District 1 with no success. It is an African American district. Fairfield Behavioral Health could not get \$26,500 to be added to their budget. This budget represents the Council and represents who we are. The budget this year increased \$1.3M. This represents no projects in rural, poor and black neighborhoods, and Council Member Bell questioned why. When salary, people and departments come up that reflect other things, that person was added. The Sheriff's Department could not get three additional cars, and this department has a big impact on the neighborhoods. Council Member Bell again stated 57% of the budget is salary and fringe. Where are the projects and where are the projects in rural communities and communities of color. This budget reflects who we are and what our priorities are. Council Member Bell feels people may not like him, and he cannot make them like him, but he feels he will be on the right side of history. He will do what is needed and speak up for people who are struggling, impoverished and communities of color. He feels the County must do better.

Council Member Pauley will not dispute the facts stated by Council Member Bell. He will dispute that a community center is the only thing to get people healthy. A year ago, Council Member Pauley decided he was unhealthy and decided to make a change. He lost 40 pounds, now runs 6 miles a day and has not been to a community center or a gym. If people want to get healthy, no matter what color, this can be done if it is your desire. You do not need a community center to get healthy. Council Member Bell understands this, but we have Drawdy Park fitness center, Mt. Zion, Boykin Recreation Center all within 1.5 miles and questioned this.

Chairman Robinson stated the County is partnering with Robinson: Harvest Hope Mobile Food Pantry on May 16, May 23 and May 30. On May 16, the pantry will be located at Fairfield County Administration Building between the hours of 12 and 2. You will be able to drive through and get a County tote bag filled with food. On May 23, it will be located at Ridgeway Fire Station. On May 30, it will be located at Jenkinsville Fire Station. This will be added to the County's web page.

Motion carried 6-0. Mr. Morgan stated just moments ago a third item has come to his attention that will need to be discussed This item includes: (c) Potential Retention of in executive session. Experts to Assist the County Legal Team as it Relates to a Potential Conflict Arising from the Proposed Wastewater Treatment Facility. Council Member Bell made a motion to add this item to be discussed in executive session, seconded by Council Member Gilbert. Motion carried 6-0.

Council Member Douglas was present by phone for most of the executive session and left the call at 8:49 p.m.

At 9:14 p.m., it was moved by Council Member Bell, seconded by Vice Chair Goins, to come out of executive session and return to open session. **Motion carried 5-0.** 

- A. Second Reading Ordinance No. 748: An Ordinance Authorizing Fairfield County to Purchase Certain Real Property in Fairfield County, South Carolina; Authorizing the Execution and Delivery of a Purchase Agreement, an Option Agreement and a Right of First Refusal Agreement; Authorizing the Expenditure of Certain Grant Funds; and Other Related Matters. Motion made by Council Member Gilbert, seconded by Vice Chair Goins, to approve Second Reading of Ordinance No. 748. *Motion carried 5-0.*
- **B.** Council Member Bell made a motion to authorize the County Administrator to take the necessary steps to protect Fairfield County's interests as it relates to its efforts to build a wastewater treatment facility in Fairfield County to create economic development opportunities to better the lives for the citizens of this great County of Fairfield. Motion seconded by Council Member Gilbert. **Motion carried 5-0.**
- C. Vice Chair Goins made a motion that the County Attorney be authorized to work with outside counsel to proceed with filing a request for contested case with the Administrative Law Court seeking review of the DHEC COPA Amendment process as it pertains to the sale of the Providence Health Emergency Room to ensure that the citizens of Fairfield County have a voice in maintaining their access to quality healthcare. Motion carried 5-0.

#### 16. ADJOURN

At 6:28 p.m., it was moved by Council Member Bell and seconded by Council Member Gilbert to adjourn. *The motion carried unanimously* 5-0.
