

### MINUTES REGULAR MEETING FAIRFIELD COUNTY COUNCIL JANUARY 22, 2024

### 16. COUNTY COUNCIL TIME

Mr. Gilbert made a request of Council stating since December's meeting, many citizens expressed their concerns regarding the county paying over \$1.4 million in owed taxes to the IRS. Administration received letters from the IRS. stating the county must pay overdue taxes and those letters were being investigated and the taxes were paid. As Mrs. Johnson stated at her last Council meeting, she had to pay the bills - there was no other option. If they had not been paid, the IRS could have and would have placed liens on County assessments including their operating accounts. He believed in transparency and the truth. In recent weeks, calls were made, posts flooded social media and media outlets reported their version of the truth. The reality of the truth was not what one wanted it to be but what it really was. While some might criticize them for not making the public aware of the tax bills beforehand, the Council and Administration were working together to ensure they had the facts before they made a presentation to the public. Mrs. Johnson worked tirelessly as the Interim Administrator for Fairfield County for the past year. He saw her arrive at her office early in the morning and work well into the night for the citizens of the County. When they hired Mrs. Johnson, they gave her a directive to straighten out their finances and she worked to do just that. It was unfair to her to be the victim of repeated bashing when she was only doing the job they asked her to do. She was not the cause of the IRS penalties. She made it a priority to resolve the real and present issues. In light of recent reports, he asked the Council to refer the matter to the finance committee so they could provide a detailed report for the citizens of Fairfield County - an accurate report based on facts not hearsay that sought to dramatize the issue. He understood the frustration many of them felt – it was their hard earned money. That money could have been spent on projects to help propel the county forward but the reality was unless they could successfully appeal the

fines, the money was gone and they could not get it back. What they could do was ensure it never happened again. They could support Administration in creating standard operating procedures to enhance and encourage communication between departments. They could look at ways to keep better records so that the letters from the IRS would not go unnoticed even when there was a transition in leadership. They could put a process in place to double check bills to ensure they were paid on time every time. He believed in their staff, department heads, Administration and most of all he believed pointing fingers only made the problem worse. He said instead of pointing fingers, point to solutions.

Mr. Robinson read the following: Small town politics should be a beacon of civic engagement and collaboration. We find ourselves dealing with an issue that threatens the integrity of our political system. It is meant to be in a place where ideas are exchanged and decisions are made and progress is achieved for the betterment of our community. However, a cancer has seeped into the roots of our local politics casting a dark shadow over the principles we are supposed to uphold. This cancer manifests itself in various forms. One of the most disheartening aspects of this cancer and the impact it has on our community is progress. Instead of focusing on initiatives that uplift our citizens, much of the time is spent on unraveling word games being spewed. Moreover, this cancer creates an environment of fear and mistrust amongst our citizens and residents of our town. When the political decisions are driven by personal interest rather than the common good, it undermines the very foundation of our democracy. Citizens become disappointed and they fear their voices go unheard. I encourage our citizens to do their research. (End of read statement). He said to the constituents of District 6, it was with mixed emotions that he was informing them and the public that he decided not to seek re-election for the upcoming term. Serving as their District 6 representative had been an incredibly rewarding experience and he was grateful for the trust and support he received from his constituents and colleagues. After careful consideration and reflection, he concluded that it was time for him to step back and allow a new voice and a new perspective to contribute to the growth and development of their community. He expressed his deepest gratitude to the residents of District 6 for the honor of representing them. As he transitioned out of his role, he was confident that Council would remain committed to supporting the community in any way possible. Once again he thanked them for the opportunity to serve and he looked forward to witnessing the continued progress of their community and county from a different vantage point. He then said he would close his book. He continued to say that what was going on was nonsense. He was on Council for almost 8 years. During his last year as Chairman, he worked closely with Mrs. Johnson as the Deputy Administrator. Mistakes were made but it was a

position where she learned. She did a damn good job. He did not know where or how the rumors started - it puzzled and irritated him but that cancer in the county needed to stop. The county would not grow until they put a stop to it. Mrs. Greene said she thought it was very sad to see how they shared information in the county and the outcome of sharing misinformation. There were a number of things that occurred regarding the finances in the county and what the problems were. She thought they should take a look at the information so they would know exactly what was going on because there had been a lot of misinformation shared. Resumes of people were shared and a lot of calls were made to people reading off the resume. Council had a duty to take a look at everything - background checks, reference checks, etc. What if it was one of their children applying for a job and their resume was shared all over the place? People called and said why did this person not get hired, how are you going to vote, etc. - that was not following procedures. What that did was discourage/reduce the pool of people who would apply for the job because they would know what happened before with resumes being shared. They needed to think about that. They called it being transparent but they should remember that someone's life was in the balance - someone could get fired. They could talk about the last three candidates but it went a lot farther than that. She said they should think about the responsibilities they had as citizens and as Council to try to make the best decisions they could. Mr. Ruff said he was sorry to hear that Mr. Robinson would not run again. He served with him on prior Council and enjoyed it. He hated to hear it and thanked him. It was stated earlier that there were accusations against Mrs. Johnson but it was not him. He enjoyed working with her the first time he was on Council and that time. His recommendation for the audit was not to point fingers at her or anyone but just to clear the air. He said someone mentioned that they did not care about the employees and that was absolutely not true. They did care about the employees. He recommended way back to hire Mrs. Johnson as Interim Administrator and he thought she did a great job. He wanted her and the people to know that she was still his friend and he liked her very much. They hired for Interim knowing they would look for a permanent Administrator and that was where it was going - it was not personal at all. He appreciated what she did and it did not have anything to do with that. It was about the way he compared the qualifications, experience, etc. and the way he thought the county needed to go. He knew Council cared about the employees. They had to work together and it was sad that it seemed as though there were some personal agendas but he was not a part of it. They

He agreed with Mrs. Greene regarding resumes. He was not saying that the candidates were not good ones but one could look good on paper but interviews and reference checks also had to be considered. Again, he said he was not saying that the candidates were not good candidates.

Mr. Gilbert made a motion to appoint Deputy Administrator, Synithia Williams, as the Acting County Administrator for Fairfield County for a period of time of no more than two weeks, seconded by Councilwoman Greene. *The motion carried 7-0.*










## PROJECT SUMMARY: FORECAST FOR DESIGN 2020

















## PAVEMENT REMOVAL: RUNWAY AND TAXIWAY















