

# MINUTES INAUGURATION AND ORGANIZATION MEETING FAIRFIELD COUNTY COUNCIL JANUARY 11, 2021

#### **CALL TO ORDER**

At 5:03 p.m. Senior Council Member Trapp called the Inaugural Meeting to order.

#### **INVOCATION**

Council Member Pauley led the invocation.

#### I. OATH OF OFFICE

#### II. ADJOURN

At 5:10 p.m., the Inaugural portion of the meeting was adjourned by motion of Council Member Bell and seconded by Council Member Robinson. *The motion carried unanimously 7-0*. Refreshments were served in the Conference Room.

Meeting reconvened in the Council Chambers.

#### **CALL TO ORDER**

At 5:40 p.m. Senior Council Member Trapp called the Organizational Meeting to order. Council Member Pauley made a motion to record the votes for the election of Chair and Vice Chair, seconded by Council Member Gilbert. Senior

Council Member Trapp opened the floor for discussion. Council Member Bell stated, in preparation for this meeting, he called Mr. Taylor to inquire concerning this procedure. He understood that the By-Laws state this is handled by secret ballot. He suggested Council should follow the By-Laws. Senior Council Member Trapp referred the matter to Mr. Morgan. Per Mr. Morgan, Mr. Bell is correct in that Resolution 2018-04, which is the Council By-Laws, states that the Organizational Meeting, including the election of the Chair and Vice Chair, is conducted by secret ballot by majority vote. The case law in the State of South Carolina states that if a member asks that the vote be recorded, then it becomes a public vote. This would not require a motion. Mr. Morgan is referring to an Attorney General Opinion dated March 14, 1989, to Mr. Thomas Babb, who was the Laurens County Attorney. The pertinent sections are as follows: "You have asked whether it is permissible to elect a Chairman and Vice Chairman of Laurens County Council by secret ballot. Enclosed are previous opinions issued by this office which answer the question. In Opinion Number 84-4 issued on January 17, 1984, this office concluded that if a member of Council asks that a vote be recorded, then a secret ballot could not be used in that instance." The opinion relied upon Section 30-4-90 (a) (3) of the Code of Laws. Per Mr. Morgan, this is the S.C. Freedom of Information Act section, stating "all public bodies shall keep written minutes of all their meetings. Such meetings shall include but need not be limited to . . . Subsection 3, the substance of all matters proposed, discussed or decided and at the request of any member, a record by an individual member of any votes taken." In essence, if a member of the body requests that the votes be recorded, then it takes it out of a secret ballot possibility and moves it into a vote going forward. Council Member Bell understands this, but he does not understand the fact that he had asked this question previously, and this information was not given to Council until now. Council Member Bell requested that this information be documented in the minutes. Senior Council Member Trapp inquired if a vote is needed. Per Mr. Morgan, he would say that since the Council Member has asked that the vote be recorded, it does not have to go forward with a motion and a second. Going forward, the vote for the Chair and Vice Chair would, like any other matter of business, come forward pursuant to a motion with a second followed by the vote. Council Member Greene made a motion to nominate Moses Bell as Chairman, seconded by Senior Council Member Trapp.

Bell: Thanked the Council for electing him to serve as Chair realizing there will be a learning curve. He does believe in transparency, and he will strive for the County to work together and do the things needed for the communities. Council Member Robinson inquired if Council will transition from County focus to community focus and if this will be the new direction. Per Chairman Bell, he feels this is all inclusive. There is ample case law coming out of Anderson and Greenville Counties discussing the length of an Administrator's contract. This is why it is two years. Going forward at this point in time, Mr. Taylor is still the County Administrator but is just not operating under a contract per se.
