3. The project consists of the following generally described work:

Demolition and removal of existing bridge structure, approximately 78-feet in length by 18-feet wide, that crosses over Dutchman's Creek. The existing bridge consists of concrete piers, timber pile caps, steel stringers, timber stringers, timber decking, timber wearing boards, timber curbing and timber abutments. The Project includes a new concrete bridge that will be located approximately 80-linear feet downstream of the current bridge site. The new bridge is approximately 100- feet in length by 54-feet wide, excluding roadway approaches. Roadway approaches improvements includes clearing and grubbing, grading, asphalt paving, gravel paving, and erosion control.

5. Bids can be mailed, or hand delivered to the Fairfield County address above; however, persons delivering in-person will not be permitted to stay for the bid opening in order to maintain social distancing. They will be required to utilize the live streaming link or conference call number.
6. Bids shall be accompanied by a bid bond or certified cashier's check in an amount not less than 10% of the base bid. All bonds shall be by a surety company licensed in **South Carolina** with an "A" minimum rating of performance and a financial strength of at least five times the contract price as listed in the most current publication of "Best's Key Rating Guide Property Liability." Performance and Payment Bonds, each in an amount equal to 100% of the contract price shall be required of the successful bidder if contract is awarded. Each Bond shall be accompanied by a "Power of Attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond.
7. Owner reserves the right to reject any or all Bids, including without limitation, the rights to reject any or all nonconforming, nonresponsive, unbalanced or conditional Bids and to reject the Bid of any Bidder if Owner believes it would not be in the best interest of the Project to make an award to Bidder, whether because the Bid is not responsive or the Bidder is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by the Owner.
